AN ACT TO INCORPORATE THE PUBLIC SERVANTS WELFARE  
ASSOCIATION, BATAPOLA.

WHEREAS an Association called and known as “The Public Servants Welfare Association, Batapola” has heretofore been established at Batapola for the purpose of effectually carrying out and transacting all matters connected with the said Association according to the rules agreed to by its members :

Preamble.

AND whereas the said Association has heretofore successfully carried out and transacted the several objects and matters for which it was established and has applied to be incorporated and it will be for the public advantage to grant the application :

BE it, therefore, enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows :—

1. This Act may be cited as the Public Servants Welfare Association, Batapola (Incorporation) Act, No. 46 of 1981.

Short title.

2. From and after the date of the commencement of this Act, the President, Vice-Presidents and members of the Board of Management for the time being of the Public Servants Welfare Association, Batapola (hereinafter referred to as “the Association”) and such and so many persons as now are members of the Association or shall hereafter be admitted members of the Corporation hereby constituted, shall be a body corporate (hereinafter referred to as “the Corporation”) with perpetual succession under the name and style of “The Public Servants Welfare Association, Batapola” and by that name may sue and be sued in all courts, with full power and authority to have and use a common seal and to change and alter the same at its pleasure.

Incorporation of the Public Servants Welfare Association, Batapola.

3. The general objects for which the Corporation is constituted are hereby declared to be—

General objects of the Corporation.

- (a) to advance the physical, spiritual, economic, cultural and social welfare of its members ;
- (b) to promote the welfare of the children of Batapola by establishing Montessori Schools and Dhamma Schools and by granting scholarships to deserving students ; and
- (c) to promote unity and co-operation among the people in Batapola.

General  
powers  
of the  
Corporation.

4. The Corporation shall have the power to do, perform and execute all such acts, matters, and things whatsoever, as are necessary or desirable for the promotion or furtherance of the objects of the Corporation or any one of them including the power to open, operate and close bank accounts, to borrow or raise moneys with or without security, to receive or collect grants and donations, to invest its funds, and to engage, employ and dismiss personnel required for the carrying out of the objects of the Corporation.

Committee of  
Management.

5. (1) The affairs of the Corporation shall, subject to the rules in force for the time being of the Corporation, be administered by a Committee of Management consisting of the office-bearers and such number of other persons elected in accordance with the rules in force for the time being of the Corporation.

(2) The first Committee of Management of the Corporation shall consist of the office-bearers and the other members of the Committee of Management of the Association holding office on the date of commencement of this Act.

Rules

6. (1) It shall be lawful for the Corporation, from time to time, at any general meeting of the members, to make rules for the admission, withdrawal or expulsion of members, for the conduct of the duties of the Board of Management and of the various officers, agents, and servants of the Corporation, for the procedure in the transaction of business, and otherwise generally for the management of the affairs of the Corporation and the accomplishment of its objects. Such rules when made may, at like meeting, be altered, added to, amended, or revoked.

(2) No rule of the Corporation for the time being in force nor any rule which may hereafter be made shall be altered, added to, amended or revoked except by a vote of two-thirds of the members present and voting at a general meeting of the Corporation.

(3) The rules of the Association in force on the date of the commencement of this Act shall be deemed to be the rules of the Corporation made under this section.

(4) The members of the Corporation shall be subject to the rules of the Corporation.

7. All debts and liabilities of the Association existing at the time of the coming into operation of this Act shall be paid by the Corporation hereby constituted, and all debts due to and subscriptions and contributions payable to the Association shall be paid to the Corporation for the purposes of this Act.

Debts due by and payable to the Association.

8. The Corporation shall be able and capable in law to take and hold any property, movable or immovable, which may become vested in it by virtue of any purchase, grant, gift, testamentary disposition, or otherwise, and all such property shall be held by the Corporation for the purposes of this Act and subject to the rules in force for the time being of the Corporation, with full power to sell, mortgage, lease, exchange or otherwise dispose of the same.

Corporation may hold property, movable and immovable.

9. The seal of the Corporation shall not be affixed to any instrument whatsoever except in the presence of either the President or a Vice-President and the Treasurer, who shall sign their names to the instrument in token of their presence and such signing shall be independent of the signing of any person as a witness.

Seal of the Corporation.

10. Nothing in this Act contained shall prejudice or affect the rights of the Republic, or of any body politic or corporate, or of any other persons, except such as are mentioned in this Act and those claiming by, from or under them.

Saving of the rights of the Republic and others.
